- Include the Logisnext Americas dealer branch code to be billed.
- Include the address of your local Triathlon representative.

### Validate Order

Once your order is placed, Triathlon will validate the request as being part of the program. Validated orders are transferred to Logisnext Americas electronically.

### Transaction Details

Logisnext and Triathlon will handle the transaction on behalf of the local parties.

### Order Acknowledgement

You will receive an order acknowledgment from Triathlon which will include products ordered, quantity and price.

### Billing

Upon receipt of the product at your dealership, Logisnext will bill your dealership at the locally agreed upon price and reference the original PO number submitted with your order.

### Monthly Logisnext Statement
